Financial Face-Off: Citrix vs. Parallels RAS – A Pricing Perspective



Comparing Citrix Pricing: How it stacks up next to Parallels RAS

Over the past several years, Citrix customers have expressed significant frustrations with their infrastructure. These issues might stem from the complexity of Citrix's software, complexity in the licensing models, or changes to licensing that increase annual license costs.

As a result, Citrix customers are exploring other solutions, and Parallels RAS stands out as a great alternative.

Parallels RAS is a comprehensive solution for delivering virtual applications and desktops, allowing organizations of all sizes to work securely from anywhere, on any device. It offers deployment flexibility, whether on-premises, hybrid, or in the public cloud, and integrates with existing cloud technologies like Azure Virtual Desktop.

When considering a cost comparison for virtualization software solutions, there are several areas to evaluate. Read on to explore some key areas for consideration.

Licensing has a significant impact on the running cost of an IT environment. In this case we, will be comparing licensing costs between Citrix and Parallels RAS.

In addition to those fees, there are related licensing costs to consider as well, like extra application licenses, associated Windows licensing requirements, and Azure Virtual Desktop (AVD), but these expenses are dependent on individual customer scenarios.



System infrastructure

System costs can differ depending, deployment type. These costs are generally similar for both Citrix and Parallels RAS. The exception would be if a move from on-premises to cloud would be considered, cutting the costs for server purchases and impacting this cost.



Administration and support

In many cases costs are influenced by factors like IT management hours or IT support inquiries. Switching to Parallels RAS can reduce management hours due to its simplicity.



Management infrastructure

Management infrastructure costs are relatively minor. In some scenarios, like hosted DaaS offerings, these costs are included in the service, not as separate labor costs.



Cost of migration

Migration costs vary greatly depending on the customer's current and future setups. Due to the diversity and complexity of these situations, costs truly depend on the individual circumstance.



EUC licensing

Licensing costs have a significant impact on operating costs, including application and OS licensing. In this case the comparison will be against Citrix and Parallels RAS and use the Citrix pricing from insight.com.

Customer scenario: CMGW Legal Services

In this section we will apply the licensing parameters described above to a fictious but representative business.

CMGW Legal Services is a provider of corporate legal software and services to over 5000 customers in Europe. They currently use a RDS implementation to grant access to customer data for 600 concurrent users.

CMGW would like to introduce new services and deliver digital workspaces via Microsoft Azure while maintaining a consistent workspace experience for all customers in their on- premises environment. They are assessing both Citrix CVAD and Parallels RAS as alternatives to their current deployment.

Due to the nature of these requirements, they will require Citrix Universal Licenses in order to deliver bothdigital workspaces and any new services with Azure via AVD and on-premises. In addition, existing contracts dictate that customer data must remain within CMGW's control, making changes costly and preventing the use of external service providers.

CMGW's IT team specializes in software services but acks expertise in VDI delivery and occasionally faces configuration issues, raising concerns about security. The CIO has budgeted for biannual staff training to address these skill gaps.

Dissatisfied with the hybrid support of their current solution and concerned about security, CMGW is searching for a flexible, easily manageable solution capable of maintaining existinglegal products and facilitating the transition to a new cloud-based solution without incurring additional licensing expenses.
